

2. PAYMENT POLICY

2.2. Payment policy:

An initial, non-refundable deposit, equivalent to [redacted] of all booked accommodation will be required no later than [redacted].

A second, non-refundable deposit, equivalent to [redacted] of all booked accommodation will be required no later than [redacted].

2.3. Personal expenses:

Guests will be responsible for their personal expenses at the Hotel Vip Executive Entrecampos Hotel and Conference.

3. ATTRITION POLICY

Adjustments to the accommodation requirements will be possible, and as per specific attrition policy, up to [redacted].

40% of all confirmed accommodation can be cancelled, at no penalties, up to [redacted]. Any cancellations of more than 40% of all confirmed accommodation will be charged to an equivalent of 50% of all cancelled revenue.

10% of all confirmed accommodation can be cancelled, at no penalties, up to [redacted]. Any cancellations of more than 10% of all confirmed accommodation will be charged to an equivalent of 75% of all cancelled revenue.

5% of all confirmed accommodation can be cancelled, at no penalties, up to [redacted]. Any cancellations of more than 5% of all confirmed accommodation will be charged to an equivalent of 100% of all cancelled revenue.

After [redacted], all cancellations will be subject to a penalty charge equivalent to 100% of all cancelled revenue.

Any cancellation must be made in written.
